Our bulk Ho Wood Essential Oil is sourced from Madagascar.</p> <p>All essential oils should be used only after being diluted in a carrier oil. Do not take internally unless under the direct supervision of a qualified practitioner. Always perform a small patch test (with the diluted essential oil) before using on skin, to check for compatibility. We strongly advise caution when using essential oils around children and pregnant women.</p>

SECTION 4 - FIRST AID MEASURES

Eye contact Contact with eyes can produce burning sensation. Rinse with water immediately, continue flushing eyes with water for 15 minutes. Seek medical attention if irritation persists.
